PAYMENT: Except those with payroll deduction, payments are due by the 5th of each month and can be turned in at the Elite Parking office located at Neal S. Blaisdell Center. Payments can be made via credit card or by check. If paying by check, make checks payable to Elite Parking Services. The return check fee is \$25.00. There will be no substitutions, vacation credit or prorated charges.

LATE PAYMENTS: Payments made after the 5th, will be assessed a \$25.00 late fee charge and may result in deactivation of your parking access card.

ACCESS CARD: There will be a non-refundable activation fee of \$25.00 for all parking access cards and for the replacement of any lost or stolen access cards. Your assigned access card allows you to park in the garage during the designated time frame listed in the policy and procedures. Access cards are to be used by assigned monthly parkers only, and may not be lent to anyone else for their use.

LIABILITY: The undersigned agrees that the City and County of Honolulu and Elite Parking Services, or the property owner, or its agents will not assume any liability to any vehicles or any articles in such vehicles whether arising through theft, collision, fire, or any other cause, or any damages or loss of use of any property. The undersigned agrees to hold the City and County of Honolulu and Elite Parking Services, or the property owner or its agents harmless from and indemnify the same against any and all liability for damages or injuries caused to the person or property of others, or to the owner and/or agent of its property.

AGREEMENT: By signing this agreement, parker acknowledges that he/she has received a copy of the Procedures and Guidelines for Parking set forth by Elite Parking Services and the City and County of Honolulu, and will abide by them while parking at the Neal S. Blaisdell Center.
